Multiple Producer Lines of Authority (LOA) on one application would be an additional \$50 registration fee per LOA.</p> <p>Fingerprint fee – If a fingerprint fee is indicated, it is only required for the first initial Producer license. Subsequent LOA additions do not require fingerprint submission and will not incur this fee unless there are certain lapses of licensure. Please see footnote.</p>
